GUIDELINES

1. **ALL CONSTRUCTION (INCLUDING NOT SHOWN BUT NEEDING APPROVAL) MUST BE DIAGRAMMED ON REVERSE SIDE.** Only new material and pressure treated wood will be approved.
2. **Fences** permitted on the side and back lots. No structures other than fences will be permitted within five feet of property lines. (This does not apply to the property line between two or more lots owned by one property owner) Max height for all fences is six feet.
3. **Chain link fences** must be galvanized with caps and top rails. Chain link fences may not create running paths for dogs to annoy other property owner's privacy. Pipe stem and any other fence material **MUST** be approved by board.
4. No drainage will be altered or added without written board consent.
5. Applicant must have and display a green construction permit in a visible front area before and during construction.
6. **Culverts** must be placed to provide adequate drainage, digging out when necessary. They must have 4 inches of surface covering. Diameter will be no less than 12"; Completed construction must be level with the road. Culverts will be made of concrete, galvanized tin horn or Sched 80 PVC or larger.

APPLICANT AGREES THAT DEVIATION FROM ATTACHED PLANS, INCLUDING THE MATERIAL SPECIFICATIONS STATED AND/OR LISTED WILL INVALIDATE APPROVAL. The ACC appreciates your cooperation in these matters.
